



## Full PhD studentship:

### “Social Imaginaries and International Collaborative Doctoral Programmes in England and Denmark. What is in it for stakeholders?”

**Eligibility:** UK and international applicants

**Award Details:** Stipend plus tuition fees

**Duration:** Full-time, up to 3.5 years fixed term

**Application deadline:** 1<sup>st</sup> March 2022

Coventry University (CU) and Aarhus University (AU) are inviting applications from suitably-qualified British and international candidates for a fully funded PhD studentship which will start in September 2022.

The successful candidate will enrol at the Centre for Global Learning ([GLEA](#)), Coventry University as their home institution and will undertake a cotutelle doctoral research programme under the supervision of academic experts from both universities, spending a minimum of one year or up to 18 months at the Centre for Higher Education Futures ([CHEF](#)), Aarhus University in Denmark.

The cotutelle programme offers doctoral researchers the opportunity to advance their skills and expertise in the higher education field, whilst developing their intercultural and international skills, and creating international networks and collaborations.

#### Details of the PhD project

The global knowledge economy, the changing nature of knowledge production, research funding mechanisms, and labour market for doctoral degree holders are driving forces that together have led to an increased interest in International Collaborative Doctoral Programmes (ICDP) in England and Denmark.

ICDP could entail negotiation of new hybrid transnational programmes changing funding landscape, pushing the boundaries of national doctorate regulations and institutional practices, building international supervisory capacity and doctoral learning ecologies, new research networks, access to additional facilities and resources, and ways of (re)orientating research themes towards the UN sustainable development goals.

Informed by a critical realist position, this PhD project focuses on international collaborative doctoral education as *policy, practice and as an object of knowledge*. It examines stakeholders' *social imaginaries* at inter/national, institutional and individual levels that make ICDP possible, giving such programmes sense and legitimacy. Here imaginaries are social because they are socially constructed and have social (and material) impacts. Such social imaginaries also have elements of moral structure (what is right) and moral agency (what is worth striving for) (Taylor, 2004).

The complexity of multi-level social imaginaries in different contexts renders challenges in conceptualising and conducting ICDP. The absence of consensus in ICDP definitions and of accurate minimum data sets precludes comparison and debate across institutions and programmes in the global north and south.

#### Project objectives:

1. Develop a conceptual classification scheme of ICDP through multi-level social imaginaries analysis and systematic literature review;
2. Explore case studies of Denmark, England and their global academic and industrial partners to understand how/why certain types of ICDP are prioritised and sustained;
3. Theorise ICDP transnational supervisory pedagogies and learning ecologies for candidates and supervisors within the case studies.



## Funding

The studentship includes

- Full tuition fees at both universities
- Stipend for up to 3.5 years (currently £15,609/year) subject to satisfactory progress
- Allowance for participating in conferences (approx. £250 per year).

## Other Benefits

- The successful candidate will receive comprehensive research training including technical, personal and professional skills at the [Doctoral College and Centre for Research Capability and Development](#) and the Centre for Global Learning at Coventry University. At Aarhus University, they will be able to take courses at the Graduate School, Faculty of Arts, and participate in the research activities of the Centre for Higher Education Futures.
- The candidate will receive excellent peer support from current doctoral and postdoctoral researchers throughout the programme.
- On completion the candidate will receive two recognized PhD qualifications, one from each university.

## Entry Requirements

To enter this cotutelle PhD programme, potential candidates must fulfil the admission requirements and be selected by CU and AU. Entry requirements include:

- A bachelor's (honours) degree in a relevant discipline/subject area with a minimum classification of 2:1 and a minimum mark of 60% in the project element (or equivalent), or an equivalent award from an overseas institution
- A master's degree with duration of 2 years or 120 ECTS, the mark for the master's dissertation (or equivalent) must be a minimum of 60%
- A research proposal (preferably with qualitative methodology)
- The potential and commitment to engage in innovative research and to complete the PhD within 3.5 years
- An adequate proficiency in English must be demonstrated by applicants whose first language is not English. The general requirement is a minimum overall IELTS Academic score of 7.0 with a minimum of 6.5 in each of the four sections, or the TOEFL iBT test with a minimum overall score of 95 with a minimum of 21 in each of the four sections.

All applications require a research proposal of max. 3,000 words (excluding references) setting out the issue for study, how the study draws on existing knowledge, and the proposed research methods and research sites for generating new knowledge. Other supporting documents include a CV, two reference letters and a covering letter of approx. 800 words showing how the applicant's experience, skills and interests are relevant to the project.
